

**Camden County Board of Education  
Special Called Meeting  
Central Office  
August 29, 2019**

The Board met in a Special Called Session meeting on Thursday, August 29, 2019, at 6:30 p.m. in the Superintendent's Office at Central Office, Camden, North Carolina. Board Members in attendance were: Christian A. Overton, Chairman, Jason Banks, Vice-Chairman, Board Members Sissy Aydlett, and Kevin Heath. Board Member Chris Purcell was not in attendance. Also, Superintendent Joe Ferrell and Billie Berry, Chief Human Resources Officer, were also in attendance.

Mr. Overton called the meeting to order at 6:30 p.m. He asked Board Members if there were any additions, deletions, or changes to be made to the August 29<sup>th</sup> Closed Session Agenda. Each member was polled. Dr. Banks added Student Confidentiality for the discussion of one item.
