

**Camden County Board of Education
Called Meeting
Central Office
July 21st, 2021**

The Camden County Board of Education met for a Called Meeting on July 21st, 2021, in the Superintendent's Office at Central Office at 6:00 p.m. Board Members in attendance were: Jason Banks, Vice-Chairman, Board Members Sissy Aydlett and Kevin Heath. Superintendent Ferrell was also in attendance. Christian Overton, Chairman, and Chris Purcell, Board Member, were not physically present but called into the meeting.

The meeting was called to order by Vice-Chairman Banks at 6:10 p.m.

Dr. Banks asked Board Members if there were any additions, deletions, or changes to be made to the July 21st Closed Session Agenda. Each Member was polled. There were no additions, deletions, or changes made to the July 21st Closed Session Agenda. Motion to approve the Closed Session Agenda was made by Dr. Banks and seconded by Mr. Heath. Superintendent Ferrell announced the following resignation:


